This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

Any beneficial interest in securities of a body where:

1. that body (to your knowledge) has a place of business or land in the area of the Council; and
2. either-
 - a. the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or
 - b. if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which the relevant person has a beneficial interest exceeds one hundredth of the total issue share capital of that class.

Other registerable interests (ORI)

ORI 1

- a. Any unpaid directorships
- b. Any body of which you are a member or in a position of general management and control either:
 - i. to which you have been appointed or nominated by the Council, or
 - ii. exercising functions of a public nature, or
 - iii. directed towards charitable purposes, or
 - iv. one of whose principal purposes includes the influence of public opinion or policy (including any political party or trade union).
